Subcommittee Reports:

- 1. **Pools/Spa** Bruce Potter/Neil Hartenstein/Jim Bowman
 - Sloan (Bruce) Furniture is out and pool will be opened as soon as water readings are satisfactory.
 - RH (Jim) pool furniture to be put out this Friday. No issues.
- 2. Gates Richard Houghton/Maria Derbyshire
 - Richard Houghton reported that he has replaced a bulb at the Fairmount gates.
- 3. Repairs Gary Wahlers/Jamie Moran
 - No report; no new issues
- 4. **Exercise Rooms** John Kerns/Bill Sirocky No issues.
- 5. **Tennis/Pickleball Courts** Courts are open and in use as weather has permitted. Tony will order a new tennis roller to replace one that is no longer satisfactory.
- 6. Night Watch Jim Varvaris/Bill Sirocky No issues

Old Business

- 1. Sloan gym recumbent bike John Kerns reported that the bike has been repaired satisfactorily.
- 2. **Clubhouse Rental Rules** Maria Derbyshire reported the revised rules have been approved by the Board and are now posted on the RAP website.
- 3. Status of RH Gate Maria reported there is no new information; estimated date of installation unknown.
- 4. **Replacement of Slings for Outdoor Furniture** Bruce Potter plans to complete one lounge chair before the May 23 open Board meeting.

New Business:

- 1. **Oven at RH**: Maria reported that the glass in the door of the RH oven shattered during a self-cleaning cycle, sending broken glass out through the vent. Maria contacted the manufacturer. They were most concerned about possible injuries (none, except cut hand from glass cleanup). Repairs have been completed. Although the manufacturer denied any known problem, it is recommended that residents not run the self-clean cycle to prevent a recurrence.
- 2. Change Gate Closing Times Eden and Fairmount: Maria read a proposal from Todd Welsh asking that the closing time at the Fairmount and Eden gates be changed from the current 8 pm to 10 pm. He argued that this change would make it easier for both residents and guests to access the community during evening hours. There followed some discussion during which it was noted that the Phase 4 gates have always been open between the hours of 6 am and 10 pm. A motion was made to adjust the Eden and Fairmount gates times to be consistent with the Phase 4 gate times that is, open from 6 am to 10 pm. The motion carried and the proposal will be sent to the Board for further action.

Status:

- 1. Window washing at both Clubhouses has been scheduled.
- 2. Carpet cleaning at both Clubhouses has been scheduled.

Community Association Board (CAB) Liaison Report – Tom McCarthy

- The May 23 evening Board meeting will be an open meeting.
- Phase 3 mailboxes are scheduled for replacement this year.
- Wifi extender in the Sloan clubhouse has been reset following a Comcast upgrade.
- Moisture penetration Sloan clubhouse: Mary Kay has been asked to get estimates to correct flashing issues that have allowed moisture to penetrate.
- Phase 1 road sealing: Macadam, the contractor we have used to seal cracks in our roads, has said that the condition of Phase 1 roads is such that crack sealing is not sufficient and all of the roads should be resurfaced. Our reserve study suggests Phase 1 resurfacing in 2024. The Board asked Mary Kay to obtain opinions from other contractors about options for repair/resurfacing all or portions of Phase 1 roads.

<u>Additional Item:</u> Due to scheduling conflicts for the planned September 10 and October 8 FC meetings, the chairs will propose a new date for a combined September/October meeting.
