Social Committee General Meeting –January 9, 2023

Mary Phelps called the meeting to order at 7:02p.m.

Approval of minutes— Cassie D. made a motion to approve the November 14, 2022 minutes. Enid L. seconded the motion, and it passed.

Treasurer's Report— Cassie D. said the November 30, 2022 account balance was \$15,078.71 less the Good Neighbor fund of \$1,373.02 for a net balance of \$13,705.69. On December 31, 2022, the account balance was \$3,888.40 less the Good Neighbor fund of \$1,373.02 for a net balance of \$2,515.38. The holiday party produced higher than normal November receipts and higher than normal December expenses.

Activity Reports-

- Just 151 residents signed up for the December 4 RAP Holiday Dinner Dance. This figure was down 18 from 2021 and was the lowest number since its inception. Kathy Flaherty said feedback was generally favorable, but some guests did not commit to returning in 2023.
- Over forty people enjoyed themselves at the Regency Hills New Year's Eve Party. Guests commented on the variety and lovely displays.

Upcoming Events-

- Debbie McDowell said that Bravo Bagels and Dunkin Donuts would be served at the January 13 Coffee in the Clubhouse.
- Regency Hills Cocktail Parties will be held on February 11 and April 15.
- The next Sloan Cocktail Reception will take place on March 26.
- Enid Lobel said the RAP Community Passover Seder would be held on April 12. Everyone is invited.
- Ray Buckley said the Phillies Bus Trip is scheduled for May 24. Tickets will go on sale in April and attendees will travel in a Klein Transportation bus.

CAB Liaison-Bill Schalleur stated there was a surplus in the Camco year-end results. He said he was working on cash management for the roof reserve disbursement. He also asked residents to consider joining the board.

Discussion-

- Donna Varvaris explained she believed it was not feasible to hold the Progressive Dinner in October. She stated
 that she would not chair the committee, and it was not clear who would take over. Some committee members
 were in Florida and others had resigned. Kathy Flaherty said that the community might expect an annual 125150 holiday party attendance. At one time, over 200 people came to the party; however, the prices were lower
