Mary Phelps called the meeting to order at 7:00 p.m.

Discussion-

- The Social Committee members present voted unanimously to approve the bylaws changes before sending them to the Board for final approval.
- As an approved club, the Men’s Water Volleyball Club reserved the Sloan clubroom for an April pizza dinner.
- Mary P. read a statement from Facilities asking groups and individuals using both clubhouses to leave the clubrooms as they found them. Residents were to turn off the lights, reset the thermostat if changed, and return chairs and tables to their original formation.
