## Social Committee General Meeting -April 10, 2023

Mary Phelps called the meeting to order at 7:00 p.m.

**Approval of minutes**— Donna M. made a motion to approve the March 13, 2023 minutes. Holly W. seconded the motion, and it passed.

**Treasurer's Report**—Cassie D. said the March 31, 2023 account balance was \$4,419.94 less the Good Neighbor Fund of \$1,383.02 for a net balance of \$3,036.92.

## **Activity Reports**—

• Mary P. said that 85 people purchased tickets and 82 residents attended the March 26 Sloan Cocktail Party. The event was very successful and everyone approved of the new caterer.

## **Upcoming Events-**

- Debbie M. stated that 42 people were coming to the April 12 Community Passover Seder. Pumpernick's Deli will cater the Seder this year.
- Everyone is invited to the Regency Hills Cocktail Party on April 15.
- Mary P. said 86 people have purchased tickets to the May 24 Phillies Bus Trip. Ray Buckley expects to sell the remaining tickets for the second bus.
- Millie W. said a Save the Date email went out for the June 3 Community Garage Sale. Holly W. is investigating the cost of renting a helium tank for the balloons.
- Mary P. said the band Left Edge would perform at the June 25 Outdoor Gazebo Concert. She sent out a Save the Date email on March 31.
- RAP will host a July 4<sup>th</sup> Party again this year.

**CAB Liaison**—Bill Schalleur said that the board approved \$14,800 repairs to RAP's Drip Irrigation System. He said the irrigation system had problems for a number of years and Mary Tilger requested these improvements in order to complete her fall and spring clubhouse plantings. Cassie D. complemented Pristine Green on its RAP trails refurbishment.

## Discussion-

- Cassie D. was concerned that the HOA removed the defibrillators from both clubhouses. She believed the Good Samaritan Law would protect volunteers who used the AEDs. She also said that schools and many other facilities already housed these lifesaving devices. Bill S. explained that although the Good Samaritan Law protected individuals, it would not protect the HOA. He said board members were going to discuss AEDs this week. Bill S. said the only way the community could keep the AEDs in the clubhouses would be to not only pay a \$300 monthly maintenance fee but also pay annually to train some community members in their usage.
- Jane Merritt said offering CPR classes to community members could be a viable alternative. Mary P. explained that she had identified a Phoenixville company that offered CPR classes. After first assessing level of interest, Mary P. stated the Social Committee could also pay this company a flat fee to teach a class in the RAP clubhouse. Millie Wallace used to work at the township building and said a firehouse member trained township employees in CPR and AED usage.
- Rhonda G. asked if someone had updated the clubhouse first aid kits. Cassie D. and Mary P. said they were relatively new.

Since there was no further business, Millie W. made a motion to adjourn. Cassie D. seconded, and the motion passed. The meeting adjourned at 7:29 p.m.
