- The Atlantic City Casino Bus Trip reminder notice went out yesterday. This September 11 trip will cost \$40 and Resorts Casino is offering \$15 slot play. Residents can sign up and drop off checks beginning July 19.
- Cathy Sirocky is spearheading the September 20 Flu Clinic. Deb Laspas and her Costco team will give injections that day.
