

Social Committee General Meeting – May 13, 2024

- Enid L. reported that 30 people paid and 28 attended the April 24 Passover Seder. Len Lobel led participants in readings from the Haggadah, the Passover story. Afterwards, guests enjoyed a delicious meal from Pumpernick's Deli.
- On April 28, attendees appreciated the beautiful music of the Sunday Speaker Series Recorder Concert. Lea T. expects there will be a holiday concert in December.
- Mary P. reported the May 4 Kentucky Derby Cocktail Reception was a great success. Seventy-five residents attended and approximately 50 dressed up in their racing finery including fascinators and bowler hats.
