Upcoming Events-

- George Redfern said residents had signed up for the September 15 Female Artists Prior to Beyonce and Taylor presentations (8 at 2:00 and 12 at 7:00). He is emailing another invitation this week for the October 6 presentation.
- Cathy Sirocky and Deb Laspas are preparing for the October 2 Flu Clinic. Mary P. reported the Costco permission slips would be available two weeks before the clinic.
- The October 11 and November 8 Coffee at the Clubhouse meetings are on the calendar. In November, veterans will attend for free.
- An email reminder for the October 5 Regency Hills Cocktail Party will be sent out two weeks before the event.
